Oakland University's Center for Autism Summer Camp Offerings:

Adult Life Skills Camp is for adults who want to meet new friends, grow their independence skills, and learn job-related skills. Each session will be full of fun activities focused on learning life skills including practical living skills, interpersonal skills, and personal management skills. Daily Activities will include team-building, understanding employment, personal health care (such as exercise, personal hygiene, and clothing care) and campus exploration. Adult life skills campers must be independent in toileting and able to engage in activities with the support of no more than 1 adult for every 3 campers.

Adult Life Skills Camp Dates:

Session 1: Ages 18+, June 23 - July 11 (break June 30 - July 4) - 2 weeks

Session 2: **Ages 18+**, July 14 - July 25 - 2 weeks Session 3: **Ages 18+**, July 28 - Aug 8 - 2 weeks

Cost: \$750 for each two-week session.

Services in Oakland County

If you have a family member with a developmental disability he/she may be eligible for a variety of services, some at no cost to family. Oakland Community Health Network (OCHN) https://www.oaklandchn.org/ is the point of entry in Oakland County to access mental health services for adults and children with developmental disabilities, serious mental illness, and emotional disturbances. To access services, call the Non-Emergency Access & Eligibility Services Helpline (248) 464-6363. The OCHN's professional access and referral team members work with individuals and families to identify their needs, and schedule an appointment if necessary and determine eligibility based on guidelines as defined by the Michigan Mental Health Code.

MENTAL HEALTH SCHOOL NAVIGATORS

The School Mental Health Navigators work directly with the student and family through the Access/Eligibility screening process as well as assist the student and family with applying for Medicaid which will be needed in order to access services from CLS or Easter Seals-MORC. For those with developmental disabilities, the focus will be on how your child performs in the following areas:

- Self-care (can your child dress, feed, groom, toilet him or herself?)
- Self-direction (does your child need redirection/supervision, attend to a task, need to be motivated?)
- Receptive & expressive language (can your child communicate his/her needs, follow directions?)
- Capacity for independent living (is your child safe in the community/home, participate in chores?)
- Learning (can your child learn new skills/concepts, generalize and retain learned information?)
- Economic self-sufficiency (does your child understand the concept of money, manage it and pay bills?)
- · Mobility (can your child move safely through an environment and get around?)

Substantial limitations need to be found in 3 of the 7 areas to be found eligible for services.

* Note: all areas of performance are as compared to what would be typical of others the same age. *

Have the following information available: IEP's, school eligibility for special education programming, psychological testing (which should include IQ score) and documentation from a doctor that substantiates the developmental disability.

If your child is found eligible for services, the intake coordinator will set up an intake appointment for you at either Easterseals-MORC or Community Living Services of Oakland County (CLS). Both are contracted service providers through Oakland Community Health Network (OCHN). Based on your child/family's need, services may include:

- Supports coordination/case management
- Family supports/services and respite services
- Support to live independently
- In-home and community supports
- School-to-work transition supports & services and skill building If you are receiving Medicaid, there is no cost for
 the above services. If your child is 18 or older and receiving SSI (and Medicaid) there is no charge. If your child is
 under the age of 18, an ability to pay will be assessed.



Easter Seals and Macomb Oakland Regional Center (MORC) have combined to provide integrated ser They are private, non-profit, Human Service Agency that provides direct services to people with disabilities so that they may celebrate life, freedom and independence in the community. Community Living Services (CLS) of Oakland County is a private not-for-profit organization that promotes and facilitates inclusion, full citizenship, and a self-determined life for people with developmental disabilities.

CLUBHOUSES

Clubhouses are community-based programs designed to support people diagnosed with a serious mental illness in their communities. Membership is voluntary and people are typically referred to Clubhouse by their case manager. One of the components of clubhouses is the provision of employment supports. Clubhouse staff work with Clubhouse "members" to assist them in achieving their goals in the following employment categories.

Transitional Employment (TE) provides members the ability to work in a time limited position in the community, earn the prevailing wage, and gain valuable skills so they can find a permanent job at the conclusion of their transitional experience. Supported Employment (SE) and Independent Employment (IE) are both designed to assist members obtain and maintain permanent employment. SE provides additional support compared to IE through job coaching and maintaining a relationship with the employer and Clubhouse member.

Community Network Services, Easterseals-MORC, and Training and Treatment Innovations have all established Clubhouses. Please click on the links above to visit their websites.

INDIVIDUAL PLACEMENT AND SUPPORT SUPPORTED EMPLOYMENT

Individual Placement and Support Supported Employment (IPS Supported Employment) https://ipsworks.org/index.php/what-is-ips/ is an evidenced based model that helps people who have been diagnosed with a serious mental illness find work. IPS Supported Employment distinguishes itself from standard supported employment by using specific fidelity measures to achieve high employment outcomes. This model helps people gain employment in community based, integrated employment settings that pay minimum wage or above.

Some of the distinguishing features of the IPS Supported Employment model include a zero exclusion, rapid job search that emphasizes job diversity and development, time unlimited supports and working closely with mental health treatment teams. Community Network Services, Easter Seals, and Training and Treatment Innovations have all adopted the IPS Supported Employment model. Please click on the links above to visit their websites.

Kevin's Law On March 30, 2005, Kevin's Law, also referred to as Assisted Outpatient Treatment, went into effect. The purpose of Kevin's Law is to legally require adults with mental illness that refuse treatment to accept services. It pertains specifically to people whose "non-compliance" with treatment has been a factor in at least two psychiatric hospitalizations or jail sentences, or one or more acts/attempts/threats of serious violent behavior within 48 months. In partnership with Oakland County Probate Court, Oakland Community Health Network has utilized Kevin's Law to assist adults with mental illness in accessing services. OCHN utilizes the Law with caution as to not minimize people's civil liberties.
